Guidelines for Registration of Industrial Water Audit Institutions/Firms/Individual

Annexure 1

Registration of Industrial Water Audit Institutions/Firms/Individual

1. National Water Mission, MoWR, RD & GR intends to empanel Industrial Water auditor Institutions/Firms/Individual having experience and expertise in Industrial Water audit. The eligibility criteria for registration are given in this notification.

2. Registration Fees: - Rs 10000/-. The fees will be non-refundable and would be utilized for organizing meetings, workshops and printing directory.

3. Eligibility Criteria for Registration

a. The Institutions/Firms/Individual should have minimum 2 years experience in the field of industrial water auditing/start-ups firms are debarred from experience vis-à-vis approval of committee.

b. Interested applicants (with individual and institution) for empanelment may be submitted as per the Form A can be downloaded from NWM website.

c. The applicant must have relevant experience in water use efficiency, Water Resources Development & Management and experience in conducting Industrial Water audit is essential. Necessary documents / certificates / proofs and Industrial Water Audit Report prepared by the applicant should be produced. In case of start-ups, appropriate methodology along with potential outcome must be presented before committee.

d. The Institutions/Firms/Individual should have conducted at least 2 water audits in the last three years. Copy of two latest Industrial Water Audit Reports, indicating name and Certification Number and Team of professionals employed by the firm shall be clearly indicated in the report. In case of start-ups, appropriate professionals list for guidance having experience in water audit/water resources development and management is preferable.

e. The Institutions/Firms/Individual may possess the basic instruments for required for conducting Industrial Water Audit. In case, the applicant does not possess equipment, necessary proof of understanding with other institutions/ firms equipment may be submitted with the application.

List of some instruments are as follows

- Acoustic Doppler Velocimeter
- Anemometer
- Current Meter
- Flow Meter/Probe
- Electromagnetic Sensor
- Ultrasonic Flow Measurement
- Laser Based Flow Meter
- Manometer/ Pitot tube

f. The firm must have the following infrastructure facilities:

- Office Premises (permanent office address) with phone / fax
- PC System
- Audited account of statement of last two financial year/ for start-ups this clause can be relaxed.
- E-mail ID

g. Personal interview/seminar of applicants, wherever found necessary, will be taken prior to granting registration.

4. Terms & Conditions of Registration

a. The registration shall be only valid for specified period of 3 years from the date of issuance of Registration Certificate.

b. The registration is subject to yearly review and renewal by NWM and shall be liable for cancellation in case of non-performance or violation of any of the terms & conditions of registration by the consultant, specified herein.

c. The NWM Registered Industrial Water Audit firm (NWM-RIWA) shall be obliged to submit yearly Work Report pertaining to their overall activity, as NWM-RIWA, including relevant work done by them privately or under any other schemes anywhere in the country.

d. The NWM-RIWA shall respond to all or any bids, RFPs, RFQs, Tenders or quotation invited by any Industry.

e. NWM-RIWA may themselves identify and motivate prospective clients for undertaking Industrial Water audit.

f. The NWM-RIWA shall abide by the scope of work and submit Industrial Water Audit Report and also abide by the terms & conditions of National Water Mission.

g. The assignments have to be completed within time frame as agreed upon with the client in professional manner.

h. The NWM-RIWA shall be required to participate in all the meetings and workshop convened by NWM.

i. NWM-RIWA along with the representative of industries should present the finding of the Industrial Water audit before the expert committee and any modification suggested during the presentation should be incorporated in the Industrial Water audit report.

j. Certificate of Employment, duly signed by the Signatory of the Industrial Water Audit Institutions/Firms/Individual, with employment service history, shall be submitted with the application for empanelment.
